**Tuition Policy:**

- When you enroll at CNS you are reserving and purchasing a tuition slot for the time period beginning June 26, 2017 and ending August 18, 2017. **No changes will be accepted after July 1, 2017.**
- Two bills will be issued in the summer. The first will include weeks 1-4 and the second will include weeks 5-8. Tuition statements are emailed around the 15<sup>th</sup> of the month and payment is due on the 6<sup>th</sup> of the following month. By signing this enrollment contract you hereby agree to pay all tuition in the amounts as set forth on the Tuition Schedule when due. There will be a late charge at the rate of one and one quarter percent (1.25%) each month for all balances unpaid by the due date (or the maximum permissible by law if less than one and one quarter percent (1.25%) per month). A failure to pay your bill for two consecutive months may result in the withdrawal of your child from CNS.
- You agree to pay on demand all costs of collection, legal expenses and attorneys' fees incurred or paid by CNS in enforcing this enrollment contract upon your failure to pay tuition.
- Any request to withdraw from this contract must be in writing and will be reviewed by the Board for approval.
- ***There are no time substitutions for unused days, sick days or vacation days. Full Time status will take precedent when enrolling children.*** Drop hours are upon request when space is available. Please see the office staff when requesting drop hours.
